ARTICLE IV:

BY-LAWS

ARTICLE I:

SECTION 1: ACTIVE MEMBERSHIP: ADD AFTER: AND ALL CURRENT AND PAST LINE OFFICERS "IN GOOD STANDING"

ARTICLE I:

SECTION 2: DUES: ADD "THE FISCAL YEAR WILL BEGIN AND END AT THE ADJOURNMENT OF THE FEBRUARY MEETING"

ARTICLE II:

OFFICERS OF THE ASSOCIATION AND THEIR DUTIES: ADD

“SECTION 7: ASSISTANT TREASURER:

THE OFFICE OF ASST. TREASURER SHALL BE FILLED BY APPOINTMENT OF THE PRESIDENT AND THE TREASURER, WITH THE APPROVAL OF THE MEMBERSHIP. THE ASST. TREASURER SHALL ASSIST THE TREASURER IN ALL DUTIES AND PERFORM THEM IN THE TREASURER’S ABSENCE. THE ASST. TREASURER WILL NOT ENDORSE CHECKS.”

ARTICLE III

COMMITTEES OF THE ASSOCIATION AND THEIR DUTIES:

RENAME SECTION #6: “MEMBERS SICK/HOSPITALIZED”

DESCRIPTION:

IT SHALL BE THE DUTY OF THIS COMMITTEE TO READ ALOUD THE NAMES OF SICK AND HOSPITALIZED MEMBERS KNOWN TO THE MEMBERSHIP AT TIME OF SAID MEETING.

ADD SECTION #9:

Article III, Section 9, INFORMATION TECHNOLOGY/WEBSITE
The Committee shall promote, organize, and provide information as presented on the Secretary's "Annual Roster" on the website <http://fcawc.webs.com>. The website will be managed by a committee consisting of a website manager and assistant web managers appointed by the President of the Association. The website will be updated annually at minimum to coincide with roster information. Content will contain information only posture and not promote opinions or provide policy comment. It shall be the duty of the Committee to research and promote the use of the website to the benefit of all members of the Association through information technology.

WILL BE REMOVED FROM THE ROSTER. DELINQUENT AND
HONARY MEMBERS ARE NOT ENTITLED TO ANY DEATH
BENEFIT.”**
